Together, this group chartered The Defiance Area Foundation in 1979 with \$22,000 as a beginning endowment.

The Defiance Area Foundation is a tax-exempt, not-forprofit, publicly supported institution. It is a collection of funds made up of gifts, endowed funds, and bequests from individuals and corporations. These funds are pooled and invested and that income is distributed as grants. Since it is a public supported, tax-exempt corporation under IRS Code Section 501 (c) (3), all gifts are tax deductible.
