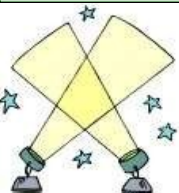
We cultivated and established 8 new funds this fiscal year:

It is through your generous support that we continue to fulfill our Mission to serve Defiance County.



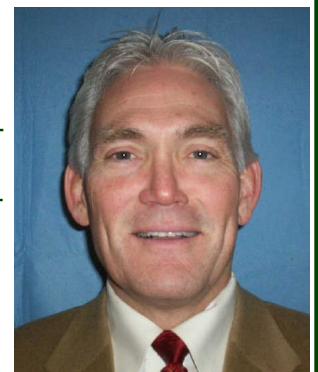
Member Spot Light

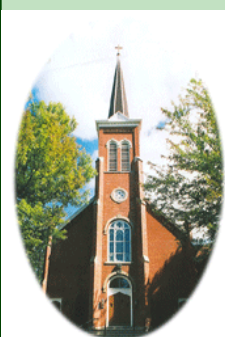
Fund Spotlight:
