Building Strong Foundations

If you want something to last, start with a strong foundation. That is the Defiance Area Foundation's theme for this year, and is directly reflected in the most recent grants we awarded.

Ground was recently broken on **Kaitlyn's Cottage** on the campus of ProMedica Defiance Regional Hospital. The Defiance Area Foundation awarded its *largest grant ever* to help with the construction of the cottage. We will be a part of this place of respite for families of special-needs children from its inception.

Education is imperative for a strong tomorrow. To help with the educational needs of children and adults in the community, the Foundation awarded a grant to **New Heights Educational**

Group, Inc. to help with the cost of online software.

Grants were also awarded from three restricted funds:

* **First Presbyterian Church** received a grant from its Capital Improvement Fund to rebuild its Washington Avenue exterior doors.

* **Defiance Public Library** received a grant to assist with ongoing renovations.

* **Defiance Elementary PTO** received a grant from a donor-advised fund to provide scholarships for fifth grade students to attend Camp Storer.

Member Spotlight: Mike Steyer

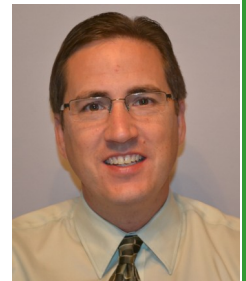

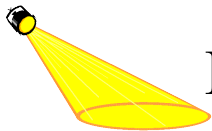

Fairview Football Scholarship Fund

In 2009, the Fairview Football Scholarship Fund was created through the Defiance Area Foundation.

Since the creation of the fund, four Fairview High School students have received scholarships: Tyler Cooper, Tyler Merillat, Nathan Yoder and William Flanary. The people who started and have supported the fund wanted to ensure that more Fairview football players could further their post-high school educations with this scholarship.

On October 22, many past Fairview High School football players, coaches and their families attended a dinner to help grow the fund.

Generous gifts were received that night from those in attendance, and numerous other gifts were received by friends who were unable to attend the event. Over \$9,000 was raised!

Everyone had a wonderful time and great memories of football days of the past are still being shared!

The event was such a success that committee members are considering holding a Fairview Football Scholarship Fund event annually.

The generosity of past Fairview football players, coaches and families will ensure a bright future for more Apache football players.

This fund was established by Fairview Alumni who realized the importance of higher education. This scholarship is awarded annually for a senior varsity football player who is going on to college (full-time). The amount will be determined annually based on the fund balance and investment return. There were two \$250 scholarships awarded for the 2011-2012 academic year. The scholarship will be payable directly to the college or university of the student's choice.
