Fall is upon us, the time change occurs November 2, and we will soon be watching the snow fall. Where has the time gone? We continue to be thankful for your support and for helping us to fulfill our mission; to enhance, enrich, encourage and support the greater Defiance area.

Our net assets totaled \$6.2 million as of 6/30/14 which included \$2.1 million in unrestricted funds. This enables The Defiance Area Foundation to grant \$83,483 to the community this fiscal year. We approved grants of \$23,000 to 5 non-profit organizations at our October Trustee Meeting. Since inception in 1979, we have granted over \$2.3 million back to Defiance County. It is with deep gratitude to our members, donors, and friends that we are able to reach so many organizations and change lives each and every day. We appreciate your continued generosity and support.
