

Grant requests from the fund will be reviewed and determined by the Advisory Committee of The Sherwood Community Fund. These recommendations will be forwarded to the Trustees of the Defiance Area Foundation for approval. The Advisory Committee will be made up of nine members from various boards and committees in the Village.

# Benefits to the Village of Sherwood

All donations and grants made to the Fund will directly benefit Sherwood. The Defiance Area Foundation adds value through marketing our fund to its constituency. Opportunities for donors to contribute through planned gifts to the Fund are created. They provide financial oversight through their Board of Directors and Finance Committee. They advise, manage, track, and promote our fund every day.

## The Partnership and Structure

Sherwood Community has partnered with The Defiance Area Foundation to create a Fund to solely benefit the Sherwood Community. This Fund has been created by several families and organizations as a donor-advised fund. Sherwood will have an advisory committee, which will serve as the "Board" for reviewing, monitoring, and overseeing the assets and grants in this fund.

#### The Investments

The Defiance Area Foundation will manage the investment of the funds, utilizing local money managers. The current investment policy consists of 60% stocks and 40% bonds. Investment information is available upon request.
