#### ~ Mission Statement ~

The Defiance Area Foundation—Serving Defiance County—is a not-for-profit organization that provides a vehicle to promote the philanthropic goals and heritage of the donors of the greater Defiance area. By preserving and nurturing the growth of its assets, The Foundation strives to enhance and enrich the quality of life in the greater Defiance area. The Foundation's mission is to encourage, through financial assistance, the starting or expansion of projects, causes, and programs that benefit a cross-section of area citizens.

## ~ What is The Defiance Area Foundation? ~

The Defiance Area Foundation—Serving Defiance County—is a tax-exempt, not-for-profit, publicly supported philanthropic institution. It is a collection of individual funds made up of gifts, endowed funds, and bequests from individuals and corporations to enhance the quality of life where they live and work. These funds are pooled and invested and that income is distributed as grants. Since it is a public supported, tax-exempt corporation under IRS Code Section 501 (c) (3), all gifts are tax deductible.

Community foundations are the fastest growing form of philanthropy and are often the first to support new and emerging needs. The Defiance Area Foundation provides a means for addressing community problems and opportunities by maintaining a broad grant program available to charitable organizations in the Defiance County area.

#### ~ Why was The Defiance Area Foundation established? ~

One man had a vision. H. Eugene Smart was a true leader and worked hard to turn his vision into a reality. His vision was to form a charitable foundation that would support programs and projects within the Defiance community. He gathered fifteen community leaders who shared a deep commitment and interest in his undertaking. Together, this group chartered The Defiance Area Foundation in 1979 with \$22,000 as a beginning endowment. From this inception, The Foundation has focused on, and participated in, the building projects and funding of programs that impact the quality of life for our citizens. The Foundation grants monies from both restricted and unrestricted funds.

- We granted money to 30 non-profit organizations in Defiance County bene4fiting hundreds of lives.
- Total grants exceeded \$364,000 to non-profit corporations during 2012-2013.
- We established partnerships with local non-profit organizations to offer educational opportunities to non-profits, profes sionals and the community (Legacy Partners).
- Eight (8) new funds / partnerships were created within the community.

#### Sufficient Grace Ministries, Inc.

Nost families enter the hospital expecting to be met with the sweet sound of a baby's cry, a joyous outcome. When joy turns to devastation, and parents face the agony of empty arms in the place of the joy they expected, *Sufficient Grace Ministries is there.* Sufficient Grace Ministries (SGM) offers bereavement resources for families who have experienced the loss of a baby through miscarriage, stillbirth, neonatal or infant death, or the death of a young child. Services are provided, free of charge, to grieving families all over the world.

Founded by Kelly Gerken, a Northwest Ohio native and mother who has experienced the loss of three of her five children, SGM began offering a specially designed line of Dreams of You memory making items and comfort products for bereaved parents in 2004. Recently the organization has expanded to offer perinatal hospice and bereavement support services to families local to Northwest Ohio who receive a fatal diagnosis in pregnancy. SGM is partnering with ProMedica Defiance Regional Hospital to offer in service training for the staff and a ground breaking, comprehensive perinatal hospice birth and bereavement support program. Services include:

- Walking with families through the journey, encouraging the family to cherish the gift of time with their baby, whether for a moment or for several months, offering continued support.
- Trained birth and bereavement doulas to offer emotional and/or spiritual support during labor and delivery and encouraging/assisting family in making memories with baby.
- Provide mementos: Dreams of You Memory Book, Comfort Bear, baby gown/layette, memorial jewelry, etc.
- Capture the precious time with baby through professional photography.

• Follow-up support for families, including a monthly support group at the SGM facilities and one-on-one peer support, if desired.



In August 1794, Anthony Wayne ordered the construction of Fort Defiance at the confluence of the Auglaize and Maumee Rivers, which became is base of operations following the Battle of Fallen Timbers, near Toledo.
